ASSUMPTION OF RISKS

With my participation in the above event, I acknowledge hereby, of my own free will and without inducements, promises or statements other than those contained in this Agreement, I am solely responsible for any certain risks of physical injury; and I agree to assume the full risk of any nature, whatsoever for any death, any injuries, damages or loss of property, and the person and the property of others, which me / my child / my extended family may sustain as a result of attending/ volunteering/participating in any and all activities connected with or associated with such a program.

Waiver and Release OF ALL CLAIMS
